- (b) This permission of conversion is also without prejudice to any of the provision of Urban Land (Ceiling & Regulation) Act, 1976 (Sec 33 of 1976) & Town & Country (Planning & Development) Act, 1979 if these are applicable to the lands involved.
- (c) This permission for conversion will be revoked if these is any violation of any of the provisions of prevailing law in force on prevention of environmental pollution affecting public health in general of the locality at any point of time.
- (d) This permission for conversion will also stand revoked if the land is used for the purpose other than the purpose for which permission is given.
- (e) The revenue shall be realized as per new amendment of W.B.L.R. Act. The revenue so determined will be subject to further adjustment against revenue and may be determined under the provision of any subsequent Act & Rule.
